## **Regulatory Analysis Summary and Supporting Documentation:**

The arts contribute more than \$2 billion per year to the Rhode Island economy. Many arts organizations operate in old and difficult to maintain buildings, and the funds necessary to operate in these structures reduce the amount and scope of programming in our state. Grants for capital improvements through this program help to expand community-based programs, which contribute to the Rhode Island economy. This amendment to the existing rule includes provisions for the 2024 Creative and Cultural Economy bonds to extend the program, aligns wording to the 2024 Voter Handbook for these bonds, and modifies certain requirements to increase flexibility in grant making and reduce administrative burden on grantees.
