Conditions for Renewal, it states, "Beginning in 2024 the applicant is responsible for submitting the full number of units, 150 professional learning units, required to renew the certificate...". This is 150 hours of additional work that teachers will not receive any compensation for, and in addition to the \$200 + expense to renew the certificate, will require educators to spend hundreds of dollars out-of-pocket to pay for these PLU's, as evident on page 62 Reg#1.8.5 B. Furthermore, the requirement for sustained learning implies that continuous college coursework or board certification is indirectly being mandated, since B.1 states "Seventy-five percent of professional learning units earned must meet the sustained professional learning requirements."

and B 2.states, "Professional learning is sustained when at least ten PLUs are earned through an activity that is 10 or more hours in length or when shorter activities of the same topic take place over time. If our LEA is only "partially responsible for providing PLU's", than the teacher is not only responsible for searching for any available learning opportunities, putting in the additional 150 hours of work and documenting the hours accrued, but is also expected to pay out-of-pocket for graduate level coursework or board certification to obtain these "sustained hours".

- I.f. the required 1 year practical residency or 60 hrs field experience. The 1 year residency is a requirement that would be hard to fulfill. These are nurses going back to school at night and working during the day. That residency would sway many potential candidates. A short field experience is built into the program now to get certified. They are required to shadow a school nurse in the school setting for 2 full school days.
- J. All grades Registered school nurse- I do not fell that there should be this pathway. The RN will have medical experience but will not have the training in the academic setting. Certified School nurse teachers are more than applying bandaids. We teach the children all day long in our office and in the classroom about asthma, head lice, germs, nutrition, health promotion, exercise.
