- 1. Please do not let this decision be based on the needs of a few districts, while the remainder of districts in RI are NOT having a hard time finding CSNTs. The urban districts, such as Providence, have a difficult time finding nurses because the work load is insane, safety is a MAJOR concern, and there is a total lack of support. I was employed in that district for four years. The number of nurses who have started and left in that time is crazy, and it had nothing to do with the certification process. Nurses, certified or not, are not going to stay in positions that are like that, especially when most nurses are taking a cut in pay when they begin working in a school. Rather than penalize the students all over the state by allowing nurses who are not prepared to be in the school setting, why not focus in on the districts that are struggling to keep nurses. Why not research why? Talk to the nurses in those districts and come up with a plan to recruit and RETAIN qualified school nurses in those districts. Bring the superintendents, administrators, and nurses in those districts together and figure out a solution that works for that district. I am telling you, getting rid of the certification requirements will not solve the problem in those districts.
- 2. Some districts do not utilize their school nurse teachers for health classes. Some, not all. I currently work at an elementary school and I am the health teacher for grades K-6. If I left my position and the school hired a nurse from the new pathway, they would also then have to hire an additional staff member to teach the health classes. It doesn't even make sense.

1.6.C.2 - Student teaching will be a "one-year practical residency and a minimum of 60 additional hours of field experiences prior to or following residency". This is onerous for people who need to work for a living while earning their teaching degree. This will also deter diverse candidates from pursuing a teaching career. It also discriminates against anyone whose economic situation forbids them from taking a year off from working in order to devote that year to uncompensated student teaching. Also, 1.8.5 RIDE defines "professional learning units" - 150 over 5 years. B.2 - sustained PLUs are 10 or more hours in length - or shorter activities over time on the same topic - and 105 of the 150 have to be sustained activities. There is a focus for educators to take college and university courses for professional development. However, 1.8.5.B. fiscal responsibility lies with educator. This does not consider the financial pressure to the educator. It seems unfair and inconsistent to require university and college courses for many candidates who already possess a master's degree. This seems like a reboot of the old "Iplan" but the Iplan had more flexibility and gave PD credit for educators involved in committees, SIT teams, etc.

It creates a situation in that only people who can afford to will pursue teaching. This will, in effect, wipe out any hope of having a diverse workforceof teachers.

1.8.5 RIDE defines "professional learning units" - 150 over 5 years. B.2 - sustained PLUs are 10 or more hours in length - or shorter activities over time on the same topic - and 105 of the 150 have to be sustained activities – like college/graduate classes. 1.8.5.B. says that fiscal responsibility lies with the educator. Essentially – a cut in pay. Not only do I have a master's degree, I took an additional equal amount of classes in the same discipline to get my teaching certificate. Now, eight years later, I just finished paying that off. Now my son is in college and my husband semi-retired. We simply cannot afford to pay for one more thing. I'd be better off getting a full time job in another field than staying in teaching and going further into debt just to maintain my certification.

I am concerned about all of the proposed regulations. I do not understand in what capacity we should be required to teach outside of our certifications. We are not certified in other areas and should not be held accountable to teach in fields outside of our areas of expertise. The students will not receive the best education if teachers who are not certified in a content area are expected to teach to it. Also, 150 PLUs are more expensive and time consuming than is reasonable to be expected in a 5 year time frame. That is 30 PLUs a year, which is the equivalent of two college courses including the accompanying coursework.
