Creating this alternate pathway will allow nurses with RN and 3 years of clinical experience (may not even have any pediatric experience and no school nurse training or experience), to function in a role that requires the education and training as is currently in place through RIDE for Certification of School Nurse Teachers. A RN that is not properly trained will not have the knowledge base to be working in this setting autonomously as a solo practitioner which can pose a risk for students safety, overall health and learning potential. We currently work as part of a team of educators and actively participate on IEP's, 504's, and serve as the health professional in the building in regards to students physical, mental and emotional health. We are the health experts that teachers, and support staff consult with when various health issues arise with students. We play an integral part in putting together Individual and Emergency Health Care Plans for students with special needs and assist in providing appropriate language and guidelines when setting up an IEP or 504 with medical provisions. A RN that is not certified will not be able to to this as they will not have the knowledge base to ensure an optimal least restrictive learning environment that has protections in place to ensure student success. We play a key part in student readiness to learn and by allowing another pathway for RN's, this will not remedy the issue for coverage but create another issue that will affect student outcomes.
