**Summary of Rulemaking Action:**

The rule sets forth the regulatory requirements for Insurance Claim Adjusters. In the last legislative session, the legislature amended one of the statutes upon which the regulation is based by virtue of 2018 P.L. chs. 298 and 321. The Department proposes to make the following substantive changes to the regulation to comport with the statutory changes and, in one instance, to clarify existing language:

§ 4.3(A)(1) and (14) – the word "body" has been removed in accordance with the statutory amendment.

§ 4.9(A)(6) – the word "and" has been added to clarify the intent of the sentence.

§ 4.10(A)(4) – the phrase "vehicle owner" is substituted for "claimant" to conform with the statute.

§ 4.10(A)(5) – the number "48" is substituted for "30" and the words "body replacement" are removed to conform with the statute.

§ 4.10(A)(6) – the number "48" is substituted for "30" and a sentence is added to conform with the statute.
