**Regulatory Analysis Summary and Supporting Documentation:** The Department has determined that small businesses will not be adversely impacted by the proposed repeal.

**Authority for This Rulemaking:** R.I. Gen. Laws Chapters 42-35, 42-17.1, 20-2, 20-4, 20-5, 20-6, and 20-7

### **Regulatory Findings:**

In the development of the proposed repeal consideration was given to: (1) alternative approaches; (2) overlap or duplication with other statutory and regulatory provisions; and (3) significant economic impact on small business. Regulations Short Title: License Suspension and Revocation Regulations

AUTHORITY: These regulations are adopted pursuant to Chapters 42-35, 42-17.1, and 20-2, of the Rhode IslandGeneral laws of 1956, as amended.

#### RI DEPARTMENT OF ENVIRONMENTAL MANAGEMENT

## ADOPTION OF REGULATIONS

The Department of Environmental Management, State of Rhode Island, acting through its Director, promulgates the following rules, pursuant to Section 42-35-1 et seq. And Section 20-2-13, of the General Laws of 1956, as amended.

Any person who is convicted of violating any provision of Title 20 of the General Laws of Rhode Island, or any rule or regulation issued pursuant thereto, and who holds a license to fish, hunt, or trap or to engage in any other activity other than Commercial Marine Fisheries, Shelllfish buyers, Lobster dealers, Finfish dealers and Multi-purpose dealers, pursuant to the provisions of Title 20, and its implementing regulations, shall have such license revoked by order of the Director, or his designee, for the period set forth in the following schedule:

1st violation - revocation for a period of 1 year

2nd violation - revocation for a period of 2 years

3rd violation and succeeding violations - revocation for a period of 3 years

No new license shall be issued to any person whose license has been revoked during the period set forth. Any person aggrieved by an order of revocation may appeal therefrom in accordance with the provisions of the Administrative Procedures Act, Chapter 35 of Title 42 of the General Laws of Rhode Island.
