"Dear Mr. Frank, I write in strong support of the proposed fee hikes at Misquamicut State Beach. I come from the perspective of a year-round Misquamicut Fire District resident. It is not the responsibility of RI taxpayers to provide a low-cost beach facility to out-of-state beachgoers. Further, Westerly taxpayers are faced with ever-increasing burdens and costs from throngs of out-of-state beachgoers. We have witnessed every year an increase in flagrant disregard of local laws regarding noise, littering, parking, traffic (speeding, lane violations, stop signs, crosswalks, etc.), alcohol use and more. One visit to the parking lot at Misquamicut will show a heavy preponderance of NY, NJ, MA and CT license plates. The current fees are so low that the State of RI actually loses money trying to operate and maintain Misquamicut Beach. What a ridiculous situation. Ironically, Rhode Islanders avoid Misquamicut Beach because it is so thronged with out-of-state visitors, making it inaccessible to the very people who pay the funds to run it.
