Thepurpose of these regulations is to establish the standards under which "NuisanceWildlife Control Specialists" may be permitted to conduct the capture, handling, disposition, exclusion and other activities as related to wildlife protected by the Department under R.I. Gen. Laws Chapter 20-1.

The Division cleaned up some language in the document and added some scientific names for species. The Division also changed the permit periods to line up. The Division also lowered the retake time period for the permit test.
