~~(a) These Rules and Regulations are being promulgated to assist board members in determining standards relative to the issuance or denial of licenses on the grounds of physical and mental fitness.~~

~~(b) These Rules and Regulations implement Title 31, Chapter 10, Section 44 of the Rhode Island General Laws and the amendments thereto.~~

III. RULE

~~(c) In reviewing license privileges after three (3) offenses for DWI or refusals, the following protocol should be utilized:~~

- ~~1. The applicant have evidence of treatment by a license professional (MD, PhD, MSW, Certified Alcohol Counselor) after the most recent offense.~~
- ~~2. That there be certification by a licensed professional that the applicant is reporting one (1) year of sobriety (the last drink or use of illicit substances was more than one (1) year ago), and that the examination done by the professional is consistent with that report.~~

IV. EFFECTIVE DATE

~~These Rules and Regulations shall become effective twenty (20) days after filing at the Office of the Secretary of State.~~
