1.0 AUTHORITY

~~These rules and regulations are adopted pursuant to the provisions of Chapters 2 and 3 of Title 31 of the General Laws of the State of Rhode Island as amended.~~

2.0 PURPOSE

~~The adoption of these rules and regulations are necessary to carry out the provisions of Chapters 1 to 27, inclusive, of Title 31 and any other laws the enforcement and administration of which are vested in the Division of Motor Vehicles and more especially to formally establish a policy within the Division of Motor Vehicles concerning the issuance of National Guard registration plates.~~

3.0 SCOPE

~~These rules and regulations refer to Section 31-3-62 of the General Laws of the State of Rhode Island as amended and govern the issuance of National Guard registration plate number one (1) and the number of such registration plates that may be issued to an eligible individual.~~

4.0 POLICY

~~National Guard plate number one (1) may be assigned only to a motor vehicle that is registered to the active Adjutant General of the Rhode Island Army/Air National Guard and only after all required registration transfer service charge and fees have been paid.~~

~~Upon termination of the active status of any individual Adjutant General, said National Guard plate number one (1) will be canceled and turned in to the Division of Motor Vehicles.~~

~~Only one (1) set of National Guard registration plates shall be issued to an individual, and an active Adjutant General who has been issued National Guard plate number one (1) shall turn in to the Division of Motor Vehicles the National Guard plate issued to him or her prior to his or her being appointed Adjutant.~~

~~Upon the expiration of his or her term, the outgoing Adjutant General shall turn in National Guard plate number one (1), but at his or her request, the plate issued prior to his or her being appointed Adjutant shall be reinstated for his or her use, subject to the payment of all required registration transfer service charges and fees.~~

5.0 EFFECTIVE DATE

~~These rules and regulations shall become effective twenty (20) days after filing with the Office of the Secretary of State.~~
