### I. <u>AUTHORITY</u>

Pursuant to the provisions of Sections 31-3-3.1 – <u>Notice to Registry of Vehicle</u> <u>Lease Agreement</u> and 42-35 of the Rhode Island General Laws, the Rhode Island Department of Administration/Division of Motor Vehicles hereby adopts and establishes the following Rules and Regulations regarding the ownership of a registered, leased <del>vehicle.</del>

#### II. <u>PURPOSE</u>:

(a) These Rules and Regulations are being promulgated to protect the interest of the public and to require notification to the Registry of Motor Vehicles at the time any leased vehicle is registered.

(b) These Rules and Regulations implement Chapter 31-3-3 of the Rhode Island General Laws and the amendment thereto, 31-3-3.1, by setting forth the manner of compliance with said amendment.

## III. RULE

(c) The Division of Motor Vehicles must be notified at the time such leased vehicle is registered by submitting the information in the spaces provided therefor on the revised Division of Motor Vehicles Form TR-1, Application for Registration and Title Certificate, a copy of which is attached and marked Exhibit "B".

# IV. EFFECTIVE DATES

These Rules and Regulations shall become effective twenty (20) days after filing

at the Office of the Secretary of State.
