Summary of Rulemaking Action:

The current rules and regulations are being amended as part of theagency's policy review to ensure the rules and regulations remain consistentwith state law and societal developments. The proposed amendments are primarily clean up in nature. For example, the agency has updated the nameof the current Superintendent, made the rules and regulations gender neutraland added gender identity as a protected class. The agency has also ensured due process protections for any sworn memberthe agency seeks to remove via a hearing for a non-work-related medical condition. Lastly, as a paramilitary organization, therules and regulations also provide the expected conduct of sworn members whencarrying out their duties and responsibilities. Over time, expectations of job performance evolve, and these amendments are reflective of these changes.

A request for an oral hearing must be made within ten (10) days of the publication of this notice.

Regulatory Analysis Summary and Supporting Documentation:

Chapter 28 of Title 42 of the Rhode Island General Lawsestablishes the authority for the Superintendent make rules and regulations notinconsistent with law for the examination and qualifications of applicants forappointment to the state police, for the discipline, control, and removal ofthe other members and relating to reimbursement for expenses properly incurred nthe performance of their official duties. The overall purpose of the rules and regulations is to provide atransparent framework of law, policy, procedures, training, and organizational expectations for the behavior of sworn members of the Rhode Island State Police.

In the development of the proposed amendment considerationwas given to: (1) alternative approaches; (2) overlap or duplication with other statutory and regulatory provisions; and (3) significant economic impact on small business. No alternative approach, duplication, or overlap was identified based upon available information. Amending these regulations will not add any financial cost to the agencyor the public at large and the societal benefits of updating rules and regulations far outweighs any concern to the contrary.
