Summary of Rulemaking Action:

The purpose of this action is to amend RIHPHC's Rules and Regulations for the State Preservation Grants. On March 2, 2021, the voters of Rhode Island approved Question 6, which authorizes the state to issue bonds for the State Preservation Grants program, which has not received new funding since 2014. The regulations have been reviewed and updated to 1) reference the new bond funding and 2) make changes and clarifications to program rules.
